Be on the lookout for New ID cards being sent to your homes. They will be sent out **December 2025** and available for use by **1/1/2026**. New ID cards are being sent due to Lac du Flambeau partnering with a new pharmacy benefit manager, Indigenous Rx powered by Liviniti.

This is a behind the scenes change to stay competitive with increasing pressure on the pharmacy market and will not affect which pharmacies Lac du Flambeau plan participants can use. You will see the new Indigenous Rx information on your new ID card. Please note: All Lac du Flambeau employees will receive the best benefit by utilizing the Peter Christensen Health Center Pharmacy located within the clinic at 129 Old Abe Road Lac du Flambeau, WI.

Any formulary (covered drug) disruptions or interruptions to your prescription drugs will be mailed out and communicated directly to affected participants. Disruptions to prescription drugs that are currently being utilized are minimal. You can download an electronic copy of your ID card by going to www.auxiant.com at any time. Health plans and issuers must include any applicable deductibles and out-of-pocket maximum limitations, and a telephone number and website address for individuals to seek consumer assistance.
